Year 7 Catch Up

The Education and Skills Funding Agency (ESFA) sends academies and free schools their year 7 catch-up premium funding. The funding for the 2017 to 2018 academic year is received on 1 March 2018. The estimate is £9972.00

From September 2016, the criteria for funding is based on percentage of students in the 2015-16 academic year who were "Catchup" with an adjustment made for the difference in cohort sizes.

The academy has identified pupils who need extra support from the year 7 catch-up premium, and we have the autonomy to decide the best way to use the funding. For 2017/18 we have detailed how we plan to use the funding below.

The 2017 cohort shows a decreasing trend in Catch-up students arriving at the academy.

2017-18 Year 7 'Catch-up' students:

The KS2 NC levels have gone and have been replaced with a scaled score. The National Expected Standard score is 100 for Reading & Mathematics.

Reading:

- 27% of Year 7 students have a KS2 Score in Reading below 100
- 8% of Year 7 students have a KS2 Score in Reading below 90

Maths:

- 5% of Year 7 students have a KS2 Score in Maths below 100
- 24% of Year 7 students have a KS2 Score in Maths below 90
